is based in the field of human rights

in particular the following laws:

o Adult Protection Act, since 2018 (which replaced the guardian law in force since 1984),

o Accommodation Act, since 1991 (UbG),

o Home Residence Act, since 2005 (HeimAufG).

Legal representation of

people with a mental illness

or an intellectual disability,

who are affected by measures restricting freedom in facilities in accordance with the HeimAufG.

Goal

Residents can live as independently as possible in the facility.

SHEET Role of resident representatives

"Lawyer function"

- Extrajudicial review of the restriction of liberty
- Representation of the residents
- to the institution and the court
- Any application for judicial review

SHEET Practical examples

1. Elderly and care facility: Ms. 89J; no adult representation; Psychiatrist Assesses Medication Decision-Making Ability; Bwin refuses medication (blood pressure); Bwin often visits the administration to get money; She is then given a sedative (Valium) in her morning coffee.

2nd hospital: male 82y; restless after urinary tract infection; unsteady gait; tries to climb over side part; is fixed day and night in bed with a waist belt. Strap open only during visiting hours.

SHEET PREVENTIVE HUMAN RIGHTS CONTROL Volksanwaltschaft

SHEET 18 years of HeimAufG - summary and outlook

... the sensitization of the facilities and especially the nursing staff regarding the human right to personal freedom has increased

... the caregivers are the central group of people, so that instead of restrictions on freedom, as many milder means and alternatives as possible are used

... there is good cooperation with many institutions

... the HeimAufG and the legal protection provided by the residents' representatives and their expertise on the HeimAufG are increasingly recognized and in demand

SHEET 18 years of HeimAufG - summary and outlook

... "mechanical" alternatives and new electronic (alarm) systems are increasingly being purchased / used

... more and more concepts that meet the needs of the residents are being implemented

... there is a great need for action to reduce the (excessive) use of psychotropic drugs

... more awareness needed regarding subtle (often unacceptable) restrictions on freedom"
